

## **Meeting of the 2020 Windemere Township Board of Canvass - November 12, 2020**

The Board of Canvass meeting was called to order at 6:04 PM by Chairman John Wesely. Others present were Supervisors Heidi Kroening & Mark Dunaski, Clerk Scott Danelski, and Treasurer Ron Mossberg. Also present, clerk-elect Cindy Woltjer.

### **OATH OF OFFICE :**

The Clerk issued the oath of office to the Windemere Township Board of Canvass members John Wesely / Heidi Kroening / Mark Dunaski.

“I, John Wesely/Heidi Kroening/Mark Dunaski do solemnly swear or affirm that I will support the Constitution of the United States and the Constitution of the State of Minnesota, and that I will discharge faithfully the duties of the office of the Windemere Township Board of Canvass in the County of Pine, the State of Minnesota, to the best of my judgment and ability.”

### **CLERK'S CANVASS REPORT & ABSTRACTS :**

The Clerk presented the Board of Canvass with the Summary Statement for the 2020 Windemere Township Election held on Tuesday November 3<sup>rd</sup>, 2020. Mark Dunaski was elected to the Windemere Township Board of Supervisors (Position “A”) with 831 votes for a 2-year term expiring on January 2<sup>nd</sup>, 2023. Heidi Kroening was elected to the Windemere Township Board of Supervisors (Position “B”) with 818 votes for a 4-year term expiring on January 6<sup>th</sup>, 2025. Cindy Woltjer was elected as the Windemere Township Clerk with 456 votes for a 4-year term expiring on January 6<sup>th</sup>, 2025. Motion by Wesely, seconded by Kroening that the Board of Canvass concurs that the Summary Statement report for the 2020 Windemere Township Election held on Tuesday November 3<sup>rd</sup>, 2020 is correct and true.

Roll Call Vote Taken: Wesely – Aye, Kroening – Aye, Dunaski – Aye. Motion Passed 3 Aye – 0 Nay.

### **BOARD OF CANVASS CERTIFICATION :**

Windemere Township Board of Canvass members John Wesely, Heidi Kroening, and Mark Dunaski signed the 2020 Board of Canvass Certification for the Windemere Township Election held on Tuesday November, 3<sup>rd</sup>, 2020.


