## March Highlights

Deposited the 2020 gas tax distribution: \$41,385.92

Processed payroll as all Direct Deposit per prior Board approval.

Hourly employees: **Special payroll this month**! Pay period ends 4/15.

New Union contract wages and benefit changes implemented:

- Retroactive to 7/1/2019
- Wage increases 2.5% year: \$36.71 (Foreman); \$25.63 (Maintenance Worker)
- Health insurance premiums increased for Township: \$865 / employee / month
- New "Training Center" benefit paid by Township: \$0.50 / hour / employee

First National reduced our interest crediting rate from 1.25% to 0.60%

Investments rate of return is down considerably to 0.65% on most recent reinvestment
