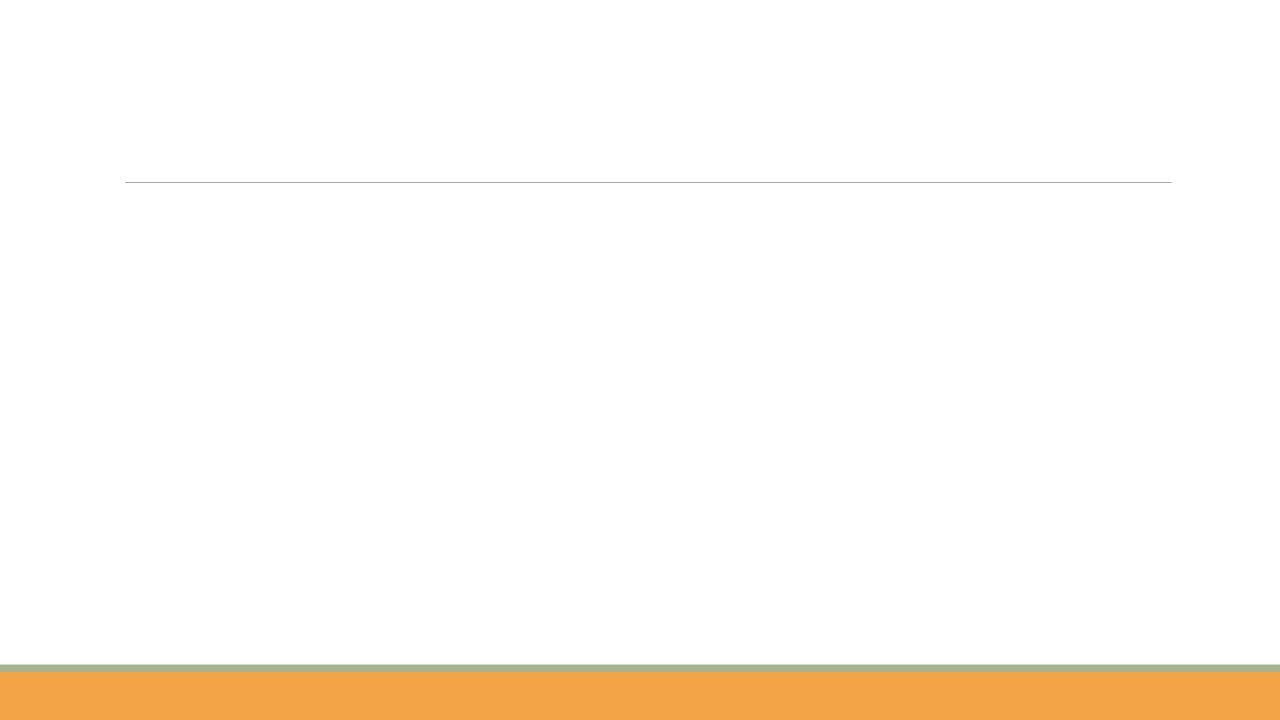

Should we move monies to First Nat'l, find other qualified investment types yielding above 0.60% or continue buying U.S. Bank Money center Bankers Acceptance?

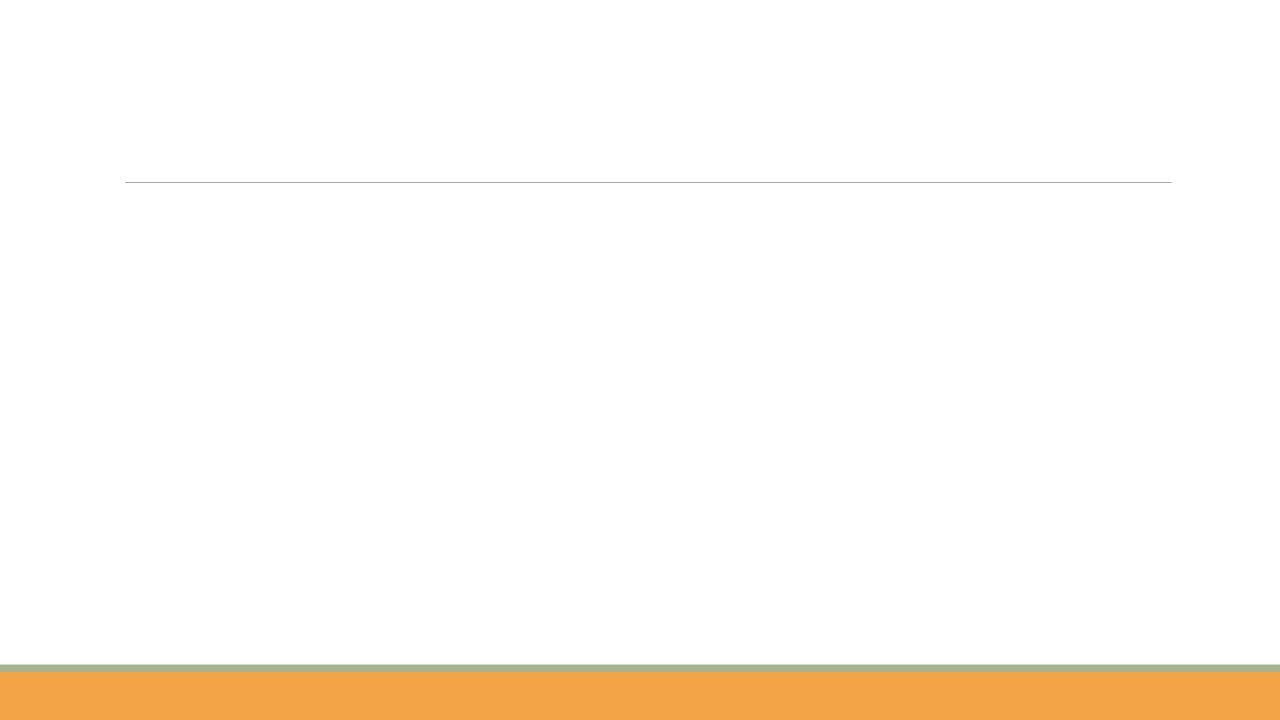
